The list of included countries is updated every **Friday**.

The list and the self-isolation requirements come into force as of **19th September 00:00**

Prohibition of passenger transportation comes into force on the **third day** after the publication of the list  
*The Cabinet's Regulation No. 360 (adopted 9 June 2020) "Epidemiological Safety Measures for the Containment of the Spread of COVID-19 Infection" (Cabinet's Regulation)\**
